### The Economic Justice Forum(EJF)Kenya: A Model for Integrated Climate, Resource, and Digital Justice Advocacy.

# 1. Executive Summary: Strategic Achievements and Future Trajectory

### 1.1. Synthesis of EJF's Integrated Justice Model

The Economic Justice Forum (EJF) operates a highly effective, vertically and horizontally integrated justice model that leverages Kenya's constitutional devolution framework to secure tangible economic, land, and environmental rights for marginalized communities. Defined as a "people-powered platform" and the "unwavering voice" of the grassroots, EJF strategically links local activism with rigorous policy research and global advocacy. This approach is evidenced by the organization's capacity to translate national constitutional mandates (such as the equitable sharing of natural resource benefits) into verifiable, county-level legislative achievements, most notably demonstrated within Taita Taveta County. The organization's philosophy is rooted in direct grassroots action, yet guided by social audits, data, and human rights research, establishing it as an evidence-driven and community-rooted entity.

### 1.2. Key Policy Impact Areas

EJF possesses a proven legislative track record that sets it apart from typical advocacy organizations. Achievements include the successful lobbying and subsequent legislation of the Taita Taveta Mining Act (2016), which institutionalized community economic empowerment through mandated benefit sharing.

Furthermore, the organization has successfully navigated complex land tenure disputes, securing the return of substantial land parcels (Mkuki Ranch 6500 acres, Manga Community Land 700 acres) and specific plot allocations for communities such as Singila Majengo, resolving rights issues dating back to 1960(300 acres)

In climate and fiscal policy, EJF has proactively engaged in cutting-edge mechanisms, advocating for Debt-for-Climate Swaps and forging strategic partnerships with high-integrity international bodies, including the Global Carbon Council (GCC) and the United Nations Environment Programme (UNEP)

### 1.3. The Al Lab as a Strategic Frontier

The proposed **Community Green Digital Justice Al-Powered Lab** (100% solar powered) represents a critical strategic pivot for EJF, transitioning from traditional civic oversight to Alenhanced algorithmic accountability and digital resource monitoring. Designed to scale participatory governance across all the devolved units.

Thi concept addresses the limitations of conventional accountability mechanisms in a decentralized system. The Lab aims to utilize digital tools to independently monitor climate and resource initiatives, ensuring resource flows are transparent and ethical AI solutions are deployed, directly combating corruption and amplifying governance reforms.

This positions EJF at the forefront of the ethical Al and civic technology movement in East Africa, focusing specifically on ensuring algorithmic fairness in the Global South.

### 1.4. Future Trajectory

EJF is strategically positioned to lead the convergence of environmental, economic, and digital rights advocacy across Kenya and potentially East Africa. By rigorously linking

verifiable local implementation lessons (e.g., from Taita Taveta) to high-level global policy debates (e.g., UN Framework on Natural Resource Benefit-Sharing and post-COP30 strategies), the organization is shifting from being a recipient of global policy to an informed co-creator. Its future trajectory involves strengthening institutional governance and scaling its verified local models through digital infrastructure, ensuring that justice is realized at the local, national, and international levels.

### 2. Introduction and Contextual Foundation

### 2.1. The Context of Economic Justice in Post-Devolution Kenya

Kenya's governance landscape has been significantly reshaped by the 2010 Constitution and the subsequent rollout of devolution, which aimed to decentralize resources and political power to 47 counties. While institutional measures have improved Kenya's fiscal transparency against the principles set out in the Fiscal Transparency Code, profound challenges persist, specifically concerning resource management and equitable public expenditure. Devolution has created new friction points regarding the governance of valuable natural assets—including minerals, land, and water—and ensuring that public finance is utilized effectively and accountably at the county level.

The Economic Justice Forum emerged as a direct response to this environment. Its vision is centered on realizing a Kenya where public finance and environmental wealth equitably uplift all, transforming marginalized communities from poverty to prosperity. The organization's work is founded on the promise that strengthening the rule of law and ensuring corporate and public sector accountability are essential for achieving broader economic accountability and social justice.

## 2.2. EJF's Vision, Mission, and Unique Community-Rooted Philosophy

EJF distinguishes itself through its unwavering focus on the marginalized and impoverished communities, including those in urban informal settlements and rural grassroots regions. Its mission, driven by experienced human rights defenders and grassroots activists, is to champion economic, tax, climate, and social justice through a combination of strategic advocacy, rigorous research, impactful coalition-building, and direct grassroots action. The philosophy guiding EJF is fundamentally community-rooted, meaning its strategies are grounded in real grassroots experiences and voices. Furthermore, its methods are evidence-driven, relying on human rights research, data, and social audits to guide policy interventions. This unique grounding allows EJF to connect localized injustices directly to high-level systemic reform debates, ensuring that its policy asks are relevant, practical, and founded on verifiable community needs.

### 2.3. Overview of the Four Strategic Pillars: The Integrated Justice Framework

EJF's work is organized around four strategic pillars that are non-linear and mutually reinforcing: Economic, Fiscal, and Social Justice; Climate & Resource Justice; Democracy, Digital Justice, Leadership & Devolution; and Global Advocacy & Governance Reform. The effectiveness of this structure lies in its integration. For instance, successfully securing land rights (Economic Justice) often involves navigating complex environmental policy (Climate & Resource Justice), which in turn requires advanced tools for monitoring and accountability (Digital Justice). This interdependency ensures that programmatic efforts produce holistic outcomes. The strategic advocacy for natural resource benefit-sharing, for example, necessitates concurrent efforts in empowering citizens to monitor public spending and demanding greater democratic accountability in devolved governance structures.

## 3. Pillar I: Deep Dive on Economic, Fiscal, and Social Justice

### 3.1. Policy Success: Institutionalizing Local Resource Benefit-Sharing

A primary achievement under this pillar is the successful legislative advocacy in Taita Taveta County. EJF led the lobbying effort resulting in the enactment of the Taita Taveta Mining Act (2016)

This local Act is vital because it operationalizes the community economic empowerment provisions outlined in the national Mining Act of 2016. The national law mandates that a portion of mining revenue (specifically 10 %) must be shared with the communities where the extraction occurs. By successfully campaigning for and securing the equivalent Act at the county level, EJF ensured that this revenue-sharing formula was institutionalized and enforceable locally. This process is crucial as it shifts the community's relationship with resource exploitation from one of passive victimhood to one of legal entitlement and local benefit maximization, including preferences for local employment and capacity building as required by the Act.

3.2. Land Tenure Security and Resolving Historical Injustices

EJF has demonstrated significant efficacy in addressing Kenya's complex legacy of land injustice, achieving tangible results in land tenure security. Specific accomplishments include the successful return of Mkuki Ranch to the Chawia Wumari Sechu Community, the return of Manga Community Land to the Manga people, and the securing of crucial plot allocations for the Singila Majengo Community from the Teita Sisal Estate.

The allocation involving Teita Sisal Estate is particularly significant as it successfully addressed historical, multi-generational squatting issues, securing rights that date back to 1960

These outcomes directly reinforce the objectives of Kenya's Land Act (2016), which designates all land in Kenya as either public, private, or community land, aiming to formalize and protect communal rights.

The successful resolution of the Manga Community case also highlights EJF's role in challenging irregular land appropriation by governmental or private entities, championing the principle of public participation required by the Constitution.

The organization's capacity to achieve these politically sensitive reforms is partially attributable to its partnership history with entities like the USAID Kenya Transition Initiative Program (KTI).

KTI historically focused on promoting fundamental reforms and managing instability post-2007 election violence, often by working with community networks and peace committees. This background suggests that EJF has the operational trust and institutional capacity necessary to undertake and successfully complete high-stakes land reform negotiations.

#### The Devolution Leverage Strategy

A critical element explaining EJF's local success is its strategic utilization of the devolved government structure.

The the organization has developed a targeted "Devolution Leverage" model. The founder/President of EJF, Christopher Mwambingu, is noted to be an alumnus of the World Partnerships program who served as an advisor to the Speaker and a member of the Taita Taveta County Assembly.

This institutional proximity and deep understanding of the county legislative process allowed EJF to bypass the slower, more centralized national policy machinery. Instead, the organization focused its legal and civic capacity on driving verifiable, constitutionally-aligned legislative change at the county level (e.g., the Taita Taveta Mining Act and Climate Change Act). This strategy significantly enhances accountability for locally managed resources, as the enforcement mechanism is directly accessible to the communities who live there.

### 3.3. Fiscal Accountability and Debt Advocacy

EJF actively engages in advanced fiscal accountability mechanisms, notably by advocating for Debt-for-Climate Swaps.

This advocacy occurs in a context where Kenya is already exploring such swaps to address sovereign debt distress and free up fiscal resources for climate investments.

EJF's forums and awareness campaigns ensure that the civic debate around these complex financial tools is centered on "justice," demanding that climate-resilient financing benefits

local communities directly, rather than merely funding large-scale national infrastructure projects. This advocacy ensures a necessary link between global financial restructuring and localized, equitable outcomes.

# 4. Pillar II: Climate Resilience and Equitable Resource Justice

### 4.1. Community-Led Carbon Initiatives and Post-COP30 Alignment

EJF is strategically engaged in pioneering community-driven carbon and biodiversity initiatives in partnership with major international organizations, including the Global Carbon Council (GCC) and Brink.

This work is explicitly aligned with the high standards and inclusionary focus of post-COP30 commitments.

The global climate discussion, particularly in the run-up to COP30 in the Amazon, emphasizes the necessity of a sustainable, regenerative "bioeconomy" that respects ethics, inclusion, and traditional communities. EJF's collaboration with the GCC is particularly noteworthy in this context. The GCC is known for its focus on digitalized, end-to-end carbon registries and adherence to high-integrity standards, including support for Article 6 implementation under the Paris Agreement.

The decision to partner with high-integrity carbon market bodies reflects a nuanced understanding of the challenges facing nature-based climate solutions in Africa. Carbon offset markets are often criticized for their lack of transparency, potential for elite capture, and negative impacts on local populations. By intentionally choosing a platform that leverages technology to digitalize and enhance traceability, EJF is attempting to establish **algorithmic trust** in climate finance flows. This positioning is designed to attract high-quality, high-premium international finance, thereby combating the inherent equity concerns that plague traditional, opaque offset schemes and validating the organization's commitment to evidence-driven integrity.

## 4.2. Advocacy for Natural Resource Benefit-Sharing (Tsavo and Mzima Springs)

Central to EJF's mission is advocacy for a robust Natural Resource Benefit-Sharing Act at the national level, focusing efforts on ensuring resources such as Tsavo National Park, Mzima Springs, and Tsavorite green garnet benefit local communities. This advocacy is constitutionally mandated; Article 69 of the Kenyan Constitution obliges the state to ensure the equitable sharing of benefits accrued from the exploitation of natural resources

The strategic focus on Tsavo National Park (Kenya's largest protected area) and Mzima Springs (a vital water source supplying Mombasa and other towns) highlights EJF's engagement in high-stakes political contestation.

Control and revenue sharing related to wildlife conservation and water resources are subjects of decades-long debate. EJF's sustained legislative pressure—including ongoing motions and petitions—aims to institutionalize benefit distribution, thereby resolving historical exclusion experienced by the host communities. Achieving a formal Natural Resource Benefit-Sharing Act is crucial because, without it, transparency and public participation in resource governance remain severely limited in practice.

### 4.3. Verifying Environmental and Leadership Impact

The "Our Trees, Our Future" project, which boasts over 20,000 trees grown and the induction of 20,000 Tree Champions offers a crucial qualitative metric for EJF's developmental impact.

The precise 1:1 ratio of trees grown to "Champions."

The program's primary goal is not maximizing sheer planting volume—which is the objective of many government initiatives —but rather prioritizing capacity building and leadership development. This deliberately links environmental stewardship directly to civic leadership, aligning perfectly with EJF's broader mission to empower youth, women, and marginalized groups in governance and resource management.

This dual focus ensures that conservation efforts are locally owned and sustainable through long-term human capital development.

# 5. Pillar III: Digital Justice, Governance, and Transformative Leadership

## 5.1. The Conceptual Framework: Community Green Digital Justice Al-Powered Lab(100% solar powered)

The proposed Community Green Digital Justice AI-Powered Lab (currently in concept stage) is EJF's most transformative strategic initiative. Its core purpose is the integration of digital tools and Artificial Intelligence (AI) to empower citizens, monitor climate and resource initiatives, and promote participatory governance across all developed units.

This project operates at the crucial **"Green Digital Justice" nexus**. Globally, there is growing alarm regarding the ethical and social impacts of proliferating AI and algorithmic decision-making, which can obscure and amplify discriminatory outcomes, often acutely affecting historically disadvantaged populations. The Lab acknowledges this risk while leveraging AI's potential for good governance.

The Lab's intended functions are twofold:

- 1. **Resource Monitoring:** Deploying digital and AI tools (such as satellite data analysis or distributed ledger technology) to provide verifiable, real-time data on resource management integrity (e.g., tracking climate finance expenditure, monitoring land use change, detecting illegal mining activity).
- 2. **Algorithmic Accountability:** Establishing mechanisms to ensure that the deployment of county-level e-governance tools, which may use Al for budget allocation or public service delivery, are ethical, inclusive, and free from inherited or programmed bias.

#### Algorithmic Accountability as a New Governance Tool

The conceptualization of the Al Lab represents an advancement into **Civic Tech 3.0** in the African context. Traditional civic oversight mechanisms—relying on periodic audits, policy briefs, and public forums—are generally too slow, resource-intensive, and unscalable to effectively monitor resource flows across devolved wards.

The Al Lab provides the necessary scalable solution by embedding **Algorithmic Accountability** directly into the civic framework. By using Al to audit and monitor *governance integrity and resource use*, EJF creates an independent oversight mechanism that can operate at the scale of modern decentralized government. This sophisticated approach positions EJF not merely as an advocacy group opposing technology, but as a pioneering organization ensuring that Kenya's rapidly advancing digital economy and national Al strategy prioritize equity, ethics, and human rights. This makes data and algorithms themselves crucial infrastructure for securing economic justice.

### 5.2. Devolution, Digital Inclusion, and Ethical Al

EJF's programs on digital inclusion aim to bridge the digital divide and ensure equitable access to digital resources.

This work is essential because, while Kenya is a leader in Africa's digital economy, this expansion introduces high risks of job precarity and deficits in decent work standards, especially for those in marginalized communities.

EJF's focus will therefore extend beyond basic access to addressing the quality and fairness of digital opportunities available.

The organization's Leadership Academy Initiatives, which empower youth and women in civic leadership, directly reinforces the long-term sustainability of the Digital Justice Lab. By building the human capital necessary to run, interpret, and utilize the outputs of the Al Lab, EJF ensures that the technology remains community-owned and people-centered, rather than being managed solely by external experts.

# 6. Pillar IV: Global Advocacy and Systemic Governance Reform

### 6.1. Connecting Local Realities to Global Justice Movements

EJF acts as a crucial vertical bridge, efficiently translating local implementation lessons into global policy demands. By securing verifiable successes in Taita Taveta (e.g., the Mining Act, Climate Change Act, and land returns), EJF establishes unique credibility in international forums.

This allows the organization to advocate for systemic global reforms, such as the proposed UN Framework/Convention on Natural Resource Benefit-Sharing, based on the practical, real-world constraints and opportunities encountered during implementation.

This leadership role involves spearheading efforts to integrate African grassroots communities into high-level global processes, including post-COP30 climate strategies and biodiversity benefit-sharing initiatives.

Such integrated advocacy aligns directly with the calls from African Civil Society Organizations (CSOs) for justice-driven outcomes at COP meetings, specifically demanding robust adaptation finance and measurable accountability for climate action.

The historical collaboration with USAID KTI also suggests a proven record of successful execution in politically sensitive areas like land

## 7. Synthesized Impact, Verifiability, and Operational Excellence

### 7.1. Integrated Impact Assessment (The Triple Bottom Line)

The integrated model deployed by EJF yields impact across social, environmental, and economic domains:

- Legislative Impact: The body of work in Taita Taveta—securing the Mining Act, the Climate Change Act, and pushing for resource benefit-sharing—serves as the definitive verifiable pilot for local policy success. These legislative wins institutionalize rights and resource distribution rather than relying on temporary political goodwill.
- **Environmental/Civic Impact:** The induction of 20,000 Tree Champions alongside the reforestation efforts is a measure of human capital development, ensuring that environmental gains are sustained by a generation of civically empowered leaders.
- Economic Opportunity: Successful land returns, particularly securing
  historical plot allocations for the Singila Majengo community, transform
  marginalized citizens from precarious squatters into legally recognized property
  owners. This move unlocks capital, self-determination, and the capacity for
  long-term community-based economic planning.

### 7.2. Geographic Focus and Scalability

EJF's geographic focus is highly strategic, targeting areas defined by acute climate vulnerability and high resource contestation.

The organization concentrates efforts in Coastal Regions (focused on blue economy and land rights), Arid & Semi-Arid Regions (ASALs, focused on climate resilience and adaptation), and Resource-Rich Counties (focused on benefit-sharing).

This tailored approach ensures that resources are deployed where developmental needs and resource governance challenges are most acute.

#### The Urban-Rural Justice Bridge

The organizational strategy of targeting both highly specific rural/resource-rich areas (like Taita Taveta or Turkana) and major Urban Centers (Nairobi, Mombasa) is not coincidental; it is a vital strategy for holistic justice. This dual focus allows EJF to connect urban demands

(e.g., for ethical digital employment, or accountability in water infrastructure like Mzima Springs which supplies Mombasa) with rural realities (e.g., resource extraction impacts, community-led climate projects). This synergy enables the organization to address the entire justice value chain, including consumption patterns, resource extraction politics, and equitable economic diversification, rather than focusing merely on localized production issues.

Crucially, the success of the local model in Taita Taveta proves the concept. The design of the **Community Green Digital Justice Al-Powered Lab** to scale across our geographical focus provides the necessary digital mechanism to transfer these lessons—including benefit-sharing monitoring and algorithmic accountability protocols—from the pilot counties to others, such as Turkana, Isiolo, or Kajiado.

### 8. Strategic Recommendations for Future Partners

Based on the evidence of EJF's effective localized advocacy, strategic use of Kenya's devolution framework, and forward-looking adoption of digital solutions, the following recommendations are presented for major institutional partners and development agencies:

### 8.1. Prioritize and Pilot the Digital Justice Lab

The 100% solar powered **Community Green Digital Justice Al-Powered Lab** represents the highest potential for scalable and verifiable governance impact.EJF has already secured land donated by the community.

The immediate funding and technical support should be secured to accelerate this project beyond the concept stage. The Lab offers a proprietary mechanism for donor partners to independently track resource flows, audit expenditure, and monitor the governance integrity of climate investments. The pilot phase will strategically be integrated with the existing accountability frameworks secured by EJF, such as the Taita Taveta Mining Act (2016) and the Taita Taveta Climate Change Act, to establish an indisputable proof-of-concept for algorithmic accountability in a verifiable legislative environment.

### 8.2. Monetizing High-Integrity Climate Assets

Facilitating acceleration between EJF, the Global Carbon Council,will result In certification and launching of the first community-driven carbon credits under the high-integrity digital registry system. The successful issuance of these traceable credits will provide a stable, long-term, market-based revenue stream for EJF, reducing reliance on short-term grant cycles. EJF will proactively market the transparency and traceability of its projects, leveraging the Post-COP30 push for ethical bioeconomies to secure premium prices for these verified carbon assets.
